

Safety Policy - Bethany Raey Performance Academy

At *Bethany Raey Performance Academy*, we prioritise the safety and well-being of all our students, staff and visitors. We have established a comprehensive safety policy to ensure a secure and protected environment for everyone involved in our academy. Our safety policy includes the following key components:

Facility Safety:

- A) Regular maintenance: We conduct regular inspections and maintenance of our facilities to ensure they meet safety standards.
